

PARENTAL/GUARDIAN CONSENT AND WAIVER OF LIABILITY

In consideration of the opportunity for my child , _____ (name of "Child") to participate in an e-Sports and Gaming Day Camp program (the "Activity") at Southeastern University, Inc. ("SEU") in months of June 2022, I, on behalf of my Child and my Child's natural and lawful parents, guardians, heirs, executors, personal representatives, and assigns, hereby:

1. Release, waive, discharge, covenant not to sue, and hold harmless SEU and its trustees, officers, administrators, servants, agents or employees (hereinafter collectively referred to as "Releasees") from any and all liability, claims, demands, damages, actions, and causes of action whatsoever arising out of or related to any loss, damage, sickness, or injury, including death, that may be sustained by my Child or to any property belonging to me or my Child while participating in the Activity or upon the premises where the Activity is being conducted;

2. Acknowledge and agree that SEU has implemented enhanced sanitation measures on its campus and increased safety and health procedures to help fight the spread of germs, but cannot guarantee that my Child will not be infected by COVID-19, and participation in the Activity could increase the risk of my child contracting COVID-19. I will help my child to understand and cooperate in complying with public health and SEU guidelines including, but not limited to: participating in daily temperature checks and other screening measures determined appropriate by SEU, washing hands regularly, keeping an appropriate distance between persons, and covering any sneeze or cough with the elbow. Further, I agree that I will keep my Child at home and not permit my Child to participate in the Activity if my Child is sick or has been in close contact with anyone else who is sick. I acknowledge the contagious nature of COVID-19 and fully assume the risk that my child may be exposed to or infected by COVID-19 by participating in the Activity;

3. Irrevocably grant SEU permission and right to photograph, video, or otherwise capture images of my Child and irrevocably permit, authorize, and license SEU to use and publish such images for purposes of promoting the Activity in perpetuity throughout the world and in any medium, format, or platform now existing or hereafter created without further consent or payment of any royalty or compensation to me or my Child;

4. Understand and agree that both my Child and I will abide by all policies established by SEU for the Activity. If SEU deems any conduct or behavior of my Child to be inappropriate, as determined by SEU in its sole discretion, SEU may suspend my Child's participation in the Activity and I will forfeit all fees paid to SEU in connection with the Activity;

5. Grant my consent for my Child to be transported by ambulance and to receive medical treatment as deemed necessary by the attending physician and other appropriate medical personnel in the event of a medical emergency, and agree to be financially responsible for any and all costs and expenses incurred in connection with such medical care or treatment rendered to my Child, and authorize and appoint any adult leader of the Activity to arrange for and consent to such transport and care in the event I cannot be located or contacted.

This Parental/Guardian Consent and Waiver of Liability shall be construed in accordance with the laws of the State of Florida. In signing this Parental/Guardian Consent and Waiver of Liability, I acknowledge and represent that: (i) I am the natural parent or legal guardian of the Child, (ii) I have read this document in its entirety and understand that I have waived substantial rights by signing this release, (iii) I have signed this document voluntarily as my own free act and deed; (iv) I am at least eighteen (18) years of age and fully competent; and (v) if any portion of this Parental/Guardian Consent and Waiver of Liability is held invalid by a court of competent jurisdiction, any portion not being held invalid shall remain in full force and effect.
